

# ONE YEAR FACTORY WARRANTY

MotorVac Technologies, Inc. ("MotorVac") warrants its new products to the original purchaser ("Purchaser") to be free from defects in material and workmanship under normal use and service for a period of twelve (12) months from the date of possession by the Purchaser, except that this warranty shall not cover failures of products that result from abuse, misuse or ordinary wear and tear of the products. THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THOSE OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE NOT EXPRESSLY SET FORTH HEREIN. This warranty is nontransferable.

The provisions of this warranty shall not apply to any product which (1) has been subject to abuse or misuse whether intentional or unintentional (in installation or operation), (2) has been repaired, altered or serviced in any manner by anyone other than an authorized MotorVac representative representative or other approved service provider, or (3) has been operated in a manner other than as specified in MotorVac's Operators Manual.

Purchaser shall inspect any products which it purchases within two (2) days after receipt thereof. Unless Purchaser within five (5) days after such inspection period notifies MotorVac in writing of any defect in or of the products delivered, it shall be conclusively presumed that Purchaser has fully inspected the delivered products and that Purchaser has acknowledged that such products are in good condition and repair, and that Purchaser has accepted such products in such good condition and repair.

For a period of twelve (12) months after the date of delivery to the Purchaser, MotorVac will, at its sole option repair or replace parts found to be defective. The foregoing is MotorVac's sole obligation and the Purchaser's exclusive remedy with respect to defective products and shall be conditioned upon receipt by MotorVac of written notice of the alleged defect within ninety (90) days from the date the alleged defect was discovered or should have been discovered, whichever occurs first. At the request of MotorVac, Purchaser will send, at Purchaser's expense, any alleged defective parts along with any forms requested by MotorVac to MotorVac at 1441 South Village Way, Santa Ana, CA 92705.

Valves and other fittings incorporated in the products have been designed to function with the detergent supplied by MotorVac Technologies Inc. Use of any other chemical or detergent could cause premature deterioration and subsequent failure of these components. Use of any chemical or detergent other than the chemical supplied by MotorVac or otherwise approved by MotorVac will void this twelve (12) month warranty.

This warranty specifically excludes any filters, external power harnesses, external supply hoses, or external adapters of the products connections except for out of box failures of such components.
